

# Volunteer Referral Program Terms & Conditions

## Utah Championship Volunteer Referral Contest — Official Terms & Conditions

**1. Sponsor.** This contest (“Contest”) is sponsored by Utah Sports Commission, 201 S Main Street STE 2125, Salt Lake City, UT 84111 (“Sponsor”). No other party is associated with or responsible for administering the Contest.

**2. Eligibility.** The Contest is open to legal residents of Utah who are 18 years of age or older at the time of entry and who are registered volunteers for the Utah Championship. Employees, officers, and directors of Sponsor and their immediate family members are not eligible. Void where prohibited by law.

**3. Contest Period.** The Contest begins on June 4<sup>th</sup>, 2026, at 12:00 A.M. MT and ends on June 23<sup>rd</sup>, 2026, at 11:59 P.M. MT (the “Contest Period”).

**4. How to Participate.** Registered volunteers (“Participants”) compete by recruiting first-time volunteers for the Utah Championship during the Contest Period. To earn credit for a referral:

- The recruited volunteer must be a first-time volunteer for the Utah Championship, as determined by Sponsor’s records.
- The recruited volunteer must list the Participant’s full name on their volunteer registration form at the time of sign-up.
- The recruited volunteer must complete registration and meet all volunteer eligibility requirements as established by Sponsor.
- Sponsor reserves the sole right to verify and confirm each referral. Self-referrals, duplicate referrals, and fictitious entries are void and will not be counted.

**5. Grand Prize and Winner Determination.** The Participant who recruits the highest number of verified first-time volunteers during the Contest Period will receive one (1) Grand Prize package (the “Grand Prize”), which includes:

- One (1) Callaway Quantum Max Driver
- Two (2) VIP tickets to Championship Sunday at the Utah Championship
- Early access to Volunteer Golf Outing registration (Participant must still meet the standard eligibility requirement of completing two (2) volunteer shifts)
- Additional prizes to be announced by Sponsor prior to the close of the Contest Period

The total approximate retail value (ARV) of the Grand Prize is a minimum of \$1,000 and will not exceed \$1,500. Winners are determined by objective count of verified referrals, not by chance.

**6. Tiebreaker.** In the event two or more Participants are tied for the highest number of verified referrals at the end of the Contest Period, the Grand Prize will be awarded to the tied Participant whose final qualifying referral was registered earliest. If a tie cannot be resolved by this method, Sponsor reserves the right to select the winner by additional objective criteria.

**7. Minimum Threshold.** A Participant must recruit at least one (1) verified first-time volunteer to be eligible for the Grand Prize. If no Participant meets the minimum threshold, Sponsor reserves the right to withhold the Grand Prize.

**8. Prize Conditions.** The Grand Prize is awarded “as-is” with no warranty or guarantee, express or implied, from Sponsor. Individual prize components are non-transferable and may

not be substituted for cash. Sponsor reserves the right to add additional prize components to the Grand Prize package at its discretion prior to the close of the Contest Period, and to substitute any individual prize component with an item of equal or greater value if the advertised component becomes unavailable. Early access to Volunteer Golf Outing registration does not waive standard eligibility requirements; the winner must still complete two (2) volunteer shifts to register.

**9. Winner Notification.** The winner will be announced on or about July 27th and notified by email using the contact information provided at volunteer registration. If the winner cannot be reached within seven days of the initial notification attempt, or if the prize notification is returned as undeliverable, the prize may be forfeited and awarded to the Participant with the next-highest verified referral total.

**10. Taxes.** All federal, state, and local taxes on the Grand Prize are the sole responsibility of the winner. The winner may be required to complete and return an IRS Form W-9 (or equivalent) before the prize is released.

**11. Publicity.** By accepting the Grand Prize, the winner grants Sponsor permission to use their name, likeness, and city/state of residence for promotional purposes in any media, without further compensation, except where prohibited by law.

**12. Release of Liability.** By participating, Participants release Sponsor, its affiliates, employees, officers, directors, agents, and representatives from any and all liability for any claims, injuries, losses, or damages of any kind arising from participation in the Contest or acceptance, use, or misuse of any prize.

**13. General Conditions.** Sponsor reserves the right to cancel, suspend, or modify the Contest if fraud, technical failure, or any other factor beyond its reasonable control impairs the integrity or proper functioning of the Contest. Sponsor reserves the right to disqualify any Participant it finds to be tampering with the referral process, submitting fraudulent referrals, violating these Terms & Conditions, or acting in a disruptive manner. Sponsor's decisions on all matters relating to the Contest are final and binding.

**14. Governing Law.** This Contest is governed by the laws of the State of Utah, without regard to its conflict of laws principles. Any disputes shall be resolved in the state or federal courts located in Salt Lake County, Utah.
